- Encouraging parents to become involved in a variety of roles such as: PAT, Booster Club, volunteering, choir, band, drama, athletics, etc. through the MAC PAT Newsletter and other means of communication.

- Douglas MacArthur Junior High School will enable and support the formation of a PAT Group--Parents & Teachers of MacArthur--a group that organizes and fosters parental and community involvement within the school. PAT is an organization made up of DMJHS parents and community members who support programs, academics, and activities for all stakeholders. Leaders of the PAT organization will be utilized in all appropriate decisions.
- · Utilize the resources of our PAT group to provide resources for families in need of support.
- Use our Career Development facilitators for the JPS district to disseminate valuable information to students and families regarding college and career readiness.
- Throughout all of its efforts, Douglas MacArthur Junior High School will promote and support responsible parenting.
- The FACE Plan will be incorporated into the school's improvement plan, and will be comprehensive and coordinated in nature.
- Resource people from our PAT group and MacArthur and/or JPS alumni to help with support for families in need. (backpack program, clothing, etc.)
- Community Resource Book- maintain a list of community resources available to staff to support the curriculum.
- DMJHS has a student clothes closet that is stocked by the general public and PAT.
- Backpacks for Kids is a program supported by donations and a budget item for our PAT organization. DMJHS
 Student Council sponsors a food drive to help fill the shelves with food items. Backpacks are provided for
 students each Friday to have food for the weekend. They are also provided during Thanksgiving, Christmas
 and Spring Break holidays.
- Junior Auxiliary of Jonesboro partners with DMJHS to provide large item needs for our students who may have lost their home, parent/guardian death.

- School supplies are provided through Stuff the Bus, Valley View Church of Christ, PAT, Arkansas State University.
- Wish List Program-anonymous student profiles are created for those students in need at Christmas including clothing, toys, supplies, toiletries. Parents and organizations select a profile and provide Christmas using the profile.
- Nationwide Insurance of Jonesboro provides a Thanksgiving meal and food for the entire Thanksgiving break for students who are on a compiled list put together by our school counselors.
- Dillard's Department Store provides clothing, shoes and jewelry for students who are elected by the student body to serve on the Snowball court.
- Student physicals are provided free of charge in April/May by Arkansas State University and St. Bernard's Regional Medical Center.
- DMJHS School Nurse provides a list of students in need of glasses after the hearing and vision screening to the Brandon Burlsworth Foundation. Each student name submitted is provided glasses through this foundation.
- Flu shots are offered free of charge by the Arkansas Health Department to the students and staff of DMJHS.
- Covid-19 vaccinations were made available to all DMJHS and JPS staff during the pandemic of 2020-21.
- Covid-19 vaccinations were later made available to all JPS students ages 16 and over, and then ages 12 and over and over in partnership with St. Bernards Health Systems.
- Band students have scholarships provided by community stakeholders through the efforts of our band director, Seth Jansen.
- The Craighead County Jonesboro Public Library's Teen Zone partners with our Library Media Specialist each spring to host author visits for Cyclone students, including free books and prizes.
- Community donations are provided across our campus for students in need. DMJHS staff, counselors, school nurse, etc. reach out across the community and seek help where and when needed. Our community is there to give to any need asked for the students of DMJHS.
- Our Parent Center is available for in-person visits and is located inside the Library Media Center, and virtually on the MAC Parent Center website (www.macparentcenter.weebly.com).

- PAT meetings are scheduled monthly in the Library Media Center and are open to all stakeholders to attend and become involved.
- A description and explanation of the curriculum can be found in the curriculum syllabus or on teacher webpages.
- Parents are provided with individual student academic assessment results and interpretations of those results.
- Progress reports are distributed regularly. Access for parents to student grades is available through HAC.
- Parents are provided with a description and explanation of the assessments used to measure student progress and achievement levels of challenging State academic standards.
- Assistance and instruction will be provided to parents of students at MacArthur in understanding Arkansas
 Academic Standards, state and local assessments including alternative assessments, and common and
 formative assessments, and Title 1, Part A requirements.
- DMJHS will build the capacity of parents by providing strategies they can use to support their child's academic progress.
- MAC Parent Center is located inside the DMJHS Library Media Center. Materials are available to check out or view in house. MAC Parent Center webpage provides resources for parents. Families may check out materials from the Parent Center, use the computers to check grades, make copies, print, or view educational resources.
- DMJHS information and announcements via social media are available for parents to view.

- Parents are encouraged to partner with teachers to build their child's academic success. This includes the two scheduled parent-teacher conferences per year, and providing school information, including links to teacher websites, MAC Library, and online grade and attendance viewer (HAC), plus the PAT Newsletter. Teachers, counselors and other staff members may offer strategies to parents to support academic success.
- Daily parenting e-Tips (English and Spanish versions) from The Parent Institute provided online via MAC social media, DMJHS school website, and MAC Parent Center website. These daily helpful tips include information on how to make sure your teen is getting enough rest, setting responsible limits on screen time, study skills, testing strategies, avoiding plagiarism, how to encourage your teen, helping teens take ownership for their future such as creating their first resume for part-time summer work, etc. As appropriate and whenever requested, role play and demonstration by trained volunteers will be made available to parents over any topic needed.
- Developmentally appropriate learning activities are incorporated such as providing current paperback books on parenting teenagers, written by parenting experts, to our 7th/8th grade families.
- ACT root word practice workbooks given to our 9th grade families so they can help their students begin preparing for college entrance exams.
- A volunteer interest survey is offered to parents/guardians to find out where/how they can volunteer on campus.
- · Parents are encouraged to join the PAT group and MAC Booster Club and get involved on campus.
- PAT and Booster Club work with school liaisons to disseminate important announcements/information via official school social media and email platforms.
- Parents will be made aware of the DESE website: http://www.arkansased.gov
- and if needed, how to utilize the tools found there.
- Counselors work with 8th and 9th grade students and parents to ensure they are making the proper course selections and career planning.
- Assistance with nutritional meal planning and preparation is also available.

- Staff is provided multiple opportunities during the summer and school year to keep current with professional development supporting the curriculum. Once every fourth year, the Arkansas Department of Education requires a two-hour Parental Involvement training session for all staff. DMJHS Administrators ensure each year that all certified and classified staff complete the required number of professional development hours as set forth by the State Department of Education.
- Teachers, specialized instructional support personnel, principals, and all other school leaders are trained and shown how parents play an integral role in student learning and how they can make valuable contributions in their child's education.
- Teachers are trained in how to reach out to and communicate with parents as equal partners, coordinate parent programs building ties between home and school, and how to welcome parents into our school to seek support and assistance. Training includes but is not limited to:
