- The Academies at JHS will work with parents to help alleviate barriers to involvement for parents i.e. transportation, child care, etc.
- Teachers will maintain up to date information about curriculum on their classroom website and Google Classroom.

- Report cards will be provided at the end of each quarter to inform parents of their student's progress in each
 academic area.
- The school will make every effort to involve and communicate with parents. To this end, opportunities for
 meetings will be offered in a variety times and formats such as, but not limited to mornings/evenings, in
 person (individually and in groups), by phone, live streamed (when appropriate), and home visits when
 possible.
- Due to a growing ELL population, the Academies at Jonesboro High invested in TransPerfect. This is a call-in interpreting service. Someone at the school calls TransPerfect and an interpreter is available. This allows the school and parent to have a conversation in the parent's home language. TransPerfect will be used when the school needs to contact parents for brief conversations. If conversations take longer than 10 minutes, parents are invited to face-to-face conferences with an interpreter present.

- The Academies at Jonesboro High School partners with several area business and community partners to
 provide in-school, as well as, out of school opportunities for students to learn about the world outside of
 high school. These opportunities include, but are not limited to internships, guest speakers, Academy
 Advisory meetings, interviews, etc.
- The Jonesboro School District partners with ASU Newport to provide college and career coaches on the campus of JHS. The college and career coaches work with students and their parents to provide information and assistance for post-secondary educational and/or career opportunities. Their work would include, but not be limited to, providing college information, assistance with ACT registration, providing assistance with the FASFA applications and other necessary paperwork for financial aid.
- The Academies at JHS will enable the formation of PTO group, a group that organizes and fosters parental
 and community involvement within the school. Leaders of this organization will be utilized in appropriate
 decisions.
- Each of the three Academies has an advisory board that is composed of parents and community business leaders, many of whom are JHS Alumni. The function of the advisory boards is to advise and help guide the direction each academy takes in preparing students for careers in their chosen field of study.
- The Academies at Jonesboro High maintains a parent resource center with pamphlets, books, and games for parents to check out at any time to take home and utilize with their child(ren).
- The Academies at Jonesboro High maintains 12 iPads equipped with a voice activated translation app parents and teachers utilize in their communication. A parent or teacher may request a device at any point in time they feel one is needed.
- School based mental health is provided for students and families through Methodist Family Health. There are two therapists and one case manager on campus working with students and families daily.
- Throughout all its efforts, The Academies at Jonesboro High will promote and support responsible parenting.
- The FACE plan will be incorporated into the school's improvement plan.
- Jonesboro Public Schools hired an ESSER Special Projects Coordinator. This person will be responsible for supporting student and community engagement by creating after school tutoring opportunities for students, organizing summer intervention programs, engaging parents and the community in services to support student learning, supporting schools with Response to Intervention, and creating opportunities for innovative services to close educational gaps due to the pandemic. This position will require someone who possesses excellent organizational and communication skills, innovative thinking, and creative community outreach ideas. This is a three year position funded through ESSER (Elementary and Secondary School Emergency Relief) Federal Funds.

- The FACE committee will schedule meetings to be held on a schedule conducive to the will of the committee. These meetings will be advertised and open to all JHS parents and partners. To the extent possible, meetings will be held at a variety of times and formats to accommodate varying parent schedules.
- Parents will be provided an explanation and description of the curriculum in use at the Academies at Jonesboro High and the assessments used to measure student progress and achievement levels during the Title I Parent meeting and through parent/teacher contacts.
- Each year ACT Aspire results are distributed to parents at parent teacher conferences. Counselors and teachers are available to go over a student's results with their parents. ACT results are sent directly to the student's home, but parents are made aware that they can contact counselors if they have questions.
- Parents may make recommendations/requests for specific workshops they would like to have offered to
 parents on a variety of topics. Workshops could include, but not be limited to "How to help your student
 succeed on the ACT", "How to succeed in High School", "How to apply for college or postsecondary
 education", "Understanding Arkansas Academic Standards, Assessments, and Title I Part A requirements",
 "Strategies for supporting student's academic success", Partnering with teachers to support student's
 academic achievement", "Utilizing appropriate learning activities at home", "How to plan and prepare
 nutritional meals at home", "How to get involved in the decisions affecting course selection, career planning
 and preparation", etc. Workshops may include but not be limited to role play and demonstrations by trained
 volunteers/personnel.

- The Academies at Jonesboro High maintains a parent center with pamphlets, books, and games for parents
 to checkout at any time. The media center also maintains a parent information page on their website
 (https://sites.google.com/jonesboroschools.net/canelibrary/home) that provides information on all aspects
 of Parent/Student engagement for High School. Topics include but are not limited to: High School Resources,
 Academic Success, Transition and Life Skills, College Preparation, Career Planning, Student Safety and
 Bullying, Parent Involvement, and Special Services.
- During the student's 9th grade year, students participate in a Key Stone class in which they map the courses they plan to take during their high school years. Parents and students are encouraged to discuss the selections students are making and map a course that leads to student success. Counselors are available to help parents in this process.

- Once every fourth year, the Division of Elementary and Secondary Education requires a two hour training session for all certified staff. This professional development is documented and retained by the school for the purpose of license renewal.

- Each year at the beginning of the school year, all staff and parents will be reminded of the integral role
 parents play in assisting student learning, as well as, the value and utility of contributions of parents. In
 addition, staff will be taught ways to reach out to, communicate with, and work with parents as equal
 partners.
